Phone line was very busy with many referrals for family members

Two meetings folded – Jenks and Midnight Special

Web was down in December and January about the same time each month. Apparently the provider wants a monthly renewal despite the service being paid for a year. She will try and resolve the issue. The person checking on the TCC add was ill. She will check on the advertisement herself.

Bus and bench advertisements are still pending depending on the outcome of the motion brought last month.

PR held an interview with the Broken Arrow Ledger. Teri thanked all who participated.

PR held a presentation with Tulsa Drug Court. It went well. The presentation took three months to arrange. She thanked Cheryl for her participation. The feedback received was all above average results from the presentation survey – with the only request that more literature be left with them. The presentation went so well, that PR is being recommended by drug court to give a presentation in April to a gathering of county DOC officials. There were lots of questions regarding sponsorship and steps,

most were outside issues. I Ps on sponsorship will be included in the thank you notes which will be sent out. Lots of discussion on signature gathering. Drug court officials suggested stamps unique to each group instead of signatures – benefits drug court because of reduced risk of forgery and benefits meetings because people will have to attend to get stamp, therefore further spreading the message (get seed of recovery planted)

Lessons to PR - PR is sorely lacking human resources to do things like stuff envelopes, write thank you notes, participate in interviews. A resource pool sign up sheet was passed to get help in these areas. If our service body votes for subcommittees to perform a task, please remember members backing is needed to help fulfill the tasks.

Letters to professional. Spoke with some professionals and was told letters are basically never seen. It was suggested letter writing was a waste of time, but asking for booth space at conventions and making presentations at conventions a much better route. PR committee will look into the cost of such things, but again needs help (people willing)

*<u>Motion 2</u> – Suspend unity meeting during campout season (July through August)

VOTE: 4 for; 10 opposed; 6 abstentions; Motion Failed

Discussion was held about requiring official receipts for reimbursements and whether to make the rule steadfast. Treasurer requested official receipts be given for reimbursements. The request is to help the treasurer with auditing and keeping people accountable.

Discussion on reimbursing Pam. W. for expenses to attend workshop on CAR report in Kansas. The groups already approved paying \$100 of the expense. - 2. should never be done under no circumstances because of the obsessive-compulsive behavior of addicts
- 3. agree addicts shouldn't be put at risk, but thinks it's dangerous for us in Oklahoma to tell south Dakota what they should do if we haven't been there
- 4. Autonomy issue doesn't affect NA as a whole, so it's a regional or individual thing
- 5. The reservation should have a tribal complex/ tribal affairs building which the group could use that isn't a casino.
- 6. some people, like those on parole can't even go into a casino
- 7. someone brought up that a convention was held in a hotel with a bar/ Asked whether we should consider that issue as well

Motion

Motion made by Teri C (PR Subcommittee)

MOTION: To place ads with Tulsa Transit Authority inside and outside of buses as wel as secure bus bench ads. PR requests \$600 from the general fund

INTENT: to finish the project started one year ago with the selling of t-shirts to get the knowledge of narcotics anonymous out to the public.

PROS:

- 1. Good idea there are a lot of people that can be reached through bus system
- 2. One member said he was the junkie asleep on the bus bench and clearly can remember an advertisement on the bench. Also saw a picture of an advertisement on a bench in the NA Way magazine.
- 3. thinks \$600 is more well spent thatn \$800 spent at the fair due to the large number of people who can be reached.

CONS:

- 1. spending \$600 on bus benches in Tulsa doesn't do anything for the communities outside of Tulsa. A large number of people and meetings in area that are not in Tulsa.
- 2. heard in PR report that the committee will be asking for more money in the future to hold round table with professionals. If asking for \$600 now and then more later. Thinks there isn't enough money to do both. Should pick and chose what needs to be done
- 3. No bus service in Pryor (for example) what can PR do for these communities. Can a lesser amount than \$600 be spent and the rest be spent doing something for communities outside Tulsa.

Teri C. explaining motion and answers to pros and cons.

PR has been held back since August because of motion after motion directing PR on what to do, but no one gets involved and actually attempts to help PR accomplish what groups are requesting. Says PR plans to do something for outlying communities but needs their input on what needs to be done (The committee can't read minds). The only people on the committee are from Tulsa. PR is not trying to focus only on Tulsa.

As for the \$600 requested now – this money comes out of the current budget. By the time the round table discussion with professionals would be held, area will be operating under a new budget.

Disbursements:

19 disbursements were made, but will be included in next treasurer's report. Gave \$500 to Region which was approved at last meeting in December.

Announcements:

Unity meeting is at 12 & 12 Feb. 2, with Meaning of the Principles hosting. Tom is speaker.

Next Area Meeting: Feb. 24, 1 p.m. in Tahlequah, Hosted by Just for Today group, 300 W. 1st St. in Tahlequah.

RCM REPORT TO AREA January 27, 2008

Region was postponed in December due to the ice storm and rescheduled for last Sunday, there was a lot to catch up on and much to discuss. The final votes were recorded on the two motions Motion for areas to send 4 representatives Failed, Motion to dissolve regional existing standing subcommittees: PI, H&I, Lit and Activities passed.

Also the weekend of February 8-10 this the General Service Assembly (GSA), this year we will be focusing on the Conference Agenda Report (CAR), this year's report has several motions for us to get the groups votes on, but focuses on Issue Discussion Topics.

I attended the CAR workshop in Kansas earlier this month and got a lot of information pertaining to the report and feed back from our Zone regarding the issues and motions. This will be presented in length at the GSA, where we will discuss the motions and have some workshops about the IDT's. The GSA is region's opportunity to give back to the areas, all meals are provided for a \$5.00 registration fee for the weekend and if you want to stay at the lodge it is 17.50/night to stay in the bunkhouse. I would like to take this opportunity to encourage all GSR's and Alternate GSR's, as well as all other interested members who can help to communicate the information to the fellowship to attend.

I also need to get some information to our RD to include in the Regions report to World.

Possibly most importantly I am available to discuss with groups the particulars for the CAR, again, I encourage you to come to the GSA where you can get the most information regarding it, along with different points of view about the topics and motions. The votes are due to the RD by the April meeting of the Region, April 14th. I have attached the 3 pages from the CAR that have the motions and Issue Discussion Topics (IDT's) listed.

Expenses for the trip to NAWS workshop in Kansas are:

Hotel - 2 nights 145.32 (72.66/night) Gas – 500 miles @ 20 miles/gallon; \$3.00/gallon = \$75.00 Food – no receipts- about \$20 on Saturday.

As the workshop was from 9 am to 6 pm staying 2 nights was necessary to stay 2 nights.

Chair's Report - We got the archives and minutes from our old secretary. Suggested we find a specific and recordable way to respond to requests to the region for correspondence or meetings. Suggested another look at the reorganization of region and how it is going to work now that the votes are in from the areas.

Regional Delegate (RD) Report - Vicky has attended 2 Plains States Zonal Forums (PSZF) here are some highlights:

- Mid-America Region has asked for input on how our out-reach works.
- PSZF was interested in how OK region will conduct business with no subcommittees.
- Topic of Casinos and Meetings: This topic is still in need of discussion by our regions since weather postponed much of the discussion this past quarter. Many feel we need to meet where ever we are needed or where there is a meeting room within our budget. The same applies to other problem areas like alcohol (bars/clubs/restaurants) in hotels. More will be revealed!

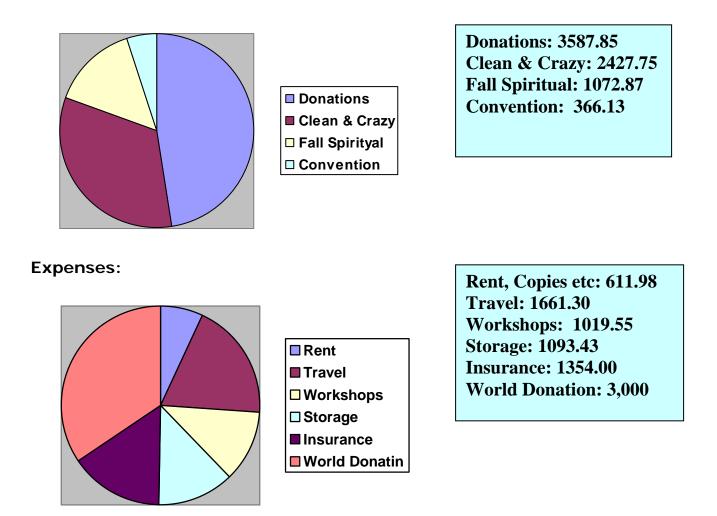
Event workbook. Dee brought final workbooks for distribution to the committees to the meeting, FSR be first committee to implement fully.
