#### CAPTURE THE FLAG FOR UNITY

The Activities committee is impressed but not surprised by the awesome, humble unity expressed by groups still participating in Capture the Flag for Unity.

For the benefit of those that haven't had access to the rules yet, here is a reposting of the current official rules as approved by Activities Committee thru group conscious.

- 'Flags' are homemade = made by group members
- Flags are captured or reclaimed by:
  - o 5 (five) home group members in the meeting room by the beginning of the opening prayer through the end of the closing prayer.
  - o announcing the intended capture during the group's announcements and confirm number of members at the closing before the prayer. This is done with respect and unity, not competition.
- A group's flag can be captured and the home group's flag reclaimed at the same meeting with 10 (ten) home group members.
- 'Out-of-town' group option:
  - o Out of town is defined as groups beyond Tulsa.
  - o Flags are captured or reclaimed by:
    - 3 (three) home group members in the meeting room by the beginning of the opening prayer through the end of the closing prayer.
    - announcing the intended capture during the group's announcements and confirm number of members at the closing before the prayer. This is done with respect and unity, not competition.
  - o A group's flag can be captured and the home group's flag reclaimed at the same meeting with 6 (six) home group members.
- Block: If at the closing, 2 groups intend to claim the same flag, both claims are blocked.

Like the Traditions, these rules will hopefully prevent very possible problems. Groups total number of members can be a point of consideration. Anonymity also means maintaining equal opportunity, even playing field.
