**The current By law reads:** – Pg.3 –IV Financial – D, ”The EASC shall have a Prudent Reserve of two months operating expenses, which shall be based upon the maximum amount expended in a two-month period during the last year, to be submitted by the treasurer on a calendar-year (each January) or a minimum amount of \$1700.

**The new By law would state:** “The EASC shall have a Prudent Reserve of two months operating expenses (except in July, August and September), which shall be based upon the maximum amount expended in a **two-month** period during the last year, to be submitted by the treasurer on a calendar-year (each January) or a Minimum amount of \$1700. In July, August and September the EASC shall have a Prudent Reserve of three months operating expenses, which shall be based upon the maximum amount expended in a three month period during the last year, to be submitted by the treasurer on a calendar-year (each January) or minimum amount of \$1700.

This is a **BY LAW CHANGE. Take back to groups. Vote next month.**  
A 2/3 majority of all voting members will be required to pass.
