David is designing a sales and inventory program for my computer. Due to the double prices on some items from Lone Star; I am having trouble. I am off about \$17.50 on the totals right now. Lone Star also over charged for my last month order by \$30.00 on the white books. We have a credit with Lone Star.

I am now responsible for making the H&I order. I have been ordering separately at cost and then I have to charge a percentage of shipping to H&I and it confuses everything on top of the fact that I cannot keep it in my inventory. I would like to order the Literature Office items and H&I items together; put it in Literature Office inventory; then sell to H&I for what the item sells (cost plus 10%) for; with no tax. This way there is no confusion on the inventory. This is just something to think about and talk over within area in new business.
