### New Business:

1. Anita P. addressed the EASC with a proposal to host the Circle of Sister Womens NA convention. Booklets containing the bid package were dispersed among the GSR's. The topic and a period of questions and answers was taken. A motion was then made before the group. Motion: Eastern Area Activites form an ad-hoc committee that would be responsible for planning and placing a bid for the Circle of Sisters Convention of Narcotics Anonymous to be hosted by the Eastern Area of Oklahoma Narcotics Anonymous no sooner than 2013. A vote was taken after a study of the EASC bylaws voting rules. The motion passed unanimously.
2. Motion- that the Outreach committee have a monthly budget of \$75 for expenses. Intent of motion: to provide monies for costs associated with visiting outlying groups, doing presentations and putting on workshops. Take to groups- vote next month.
3. Motion- To give the RCM \$150 to make copies of the information from WSC. Intent: to give a hard copy of all WSC information to groups for further use. Discussion took place because the information is available of the NA website, however RCM stated it was suggested

- by NAWs to provide the groups with a hard copy. Take to groups. Vote next month.
4. Motion- to reimburse RCM Alt. for expenses that are capped at \$300. Intent: none stated. this motion took place following a lengthy discussion on attendance at the World Workshop 9/24-9/26. The workshop is about the NA service system and the EASC decided that someone should go to represent EASC. The RCM could not attend. It was decided that the RCM Alt would attend. However, due to EASC bylaws voting rules, the EASC was unable to approve a budget for expenses incurred.
  5. Motion- to form an ad-hoc committee to review and amend the bylaws-as needed. Intent: to update the bylaws with amendments that have been added, and review the document for needed change. Vote- unanimously passed.
