 - Case # 2012 049786 has been filed and a Small Claims Case is being filed. Asking Area for \$208. to file. The EASC is moving forward with their decision to prosecute (criminal & civil).
 - NEW MOTION made by David S. & seconded by EASC member. David has requested to speak to EASC
 - Instructions given by Trent R.: Motion will be read. It is already seconded. There will be no discussion on this motion. There will be no discussion after what David has to say. And we will move right into other old business.
 - **NEW MOTION** reads: To make a New Contract with David S. to repay funds owed EASC Literature Office in the amount of \$1,970.00. The contract is to be for \$200. today, held in trust until this motion is approved or denied (held by Teresa T.) If this motion is approved the money will go to area, if not it will be returned to David S. The contract that David is proposing is to pay \$75. per week, given by David to Teresa every Thursday until David is hired on permanently. Then after permanent employment begins, David will pay \$150. every other Thursday until the debt is paid in full. This is contingent on David's continued employment and if David S. becomes unemployed or disabled, he promises to return to this meeting to make necessary arrangements.
 - Intent: To allow me to make amends, to help healing of all involved, and to give a workable means to pay back what is owed. **Take back to groups.**
- * Motion to "Raise Prudent Reserve to <u>3 months</u> funds for July, August and September months each year".

The current By law reads: – Pg.3 –IV Financial – D, "The EASC shall have a Prudent Reserve of two months operating expenses, which shall be based upon the maximum amount expended in a two-month period during the last year, to be submitted by the treasurer on a calendar-year (each January) or a minimum amount of \$1700.

The new By law would state: "The EASC shall have a Prudent Reserve of two months operating expenses (except in July, August and September), which shall be based upon the maximum amount expended in a **two-month** period during the last year, to be submitted by the treasurer on a calendar-year (each January) or a Minimum amount of \$1700. In July, August and September the EASC shall have a Prudent Reserve of three months operating expenses, which shall be based upon the maximum amount expended in a three month period during the last year, to be submitted by the treasurer on a calendar-year (each January) or

minimum amount of \$1700.
This is a BY LAW CHANGE .

A 2/3 majority of all voting members will be required to pass.
