Motion to by-laws to require all sud committee chairs to attend sub committee at OKRSC or send a representative. Failed

Does EASC want OKSRC to send a representative to planning committee for USFA. (From Region) Failed

Does EASC want OKRSC to send the RD and RDA to attend USFA in Tulsa on a information gathering (From Regoin) Failed.

Literature Money Issue:

Theft of \$2,400 from lit office by former chair. Contract was signed and presented to EASC at August meeting. To make payments of \$400 a month until money is repaid. Used world service guidelines. A letter was presented at Sept meeting stating he had purchased \$240 worth of books and gave them to a group from which he took there money from a order and he was wanting EASC to reduce his payment to \$200 a month. Much discussion occured. Motion was made to accept the \$240 payment of books then next month the contract remains the same. sent back to groups for input.

New Business:

Owasso group wants OKRSC RD and RDA to do a workshop on the new service system proposal with the current changes.

EASC want RCM to voice concerns about diverting funds without consulting the groups.

Motion aws made to unfreeze EASC spending. Passed

Motion was made to conduct a inventory of EASC in February. Sent bact to groups.

Motion for OKRSC to add to by-laws that any spending above normal operating procedures (i.e. rent, web, NAWS donations, insurance, etc) must go back to Areas to go to Groups for a vote of conscience. Sent to groups.
