Literature Report January 26, 2013

The week of Christmas of 2012 the literature office had money stolen from it. We cannot say that it had been broken into because the door or lock to the office had not been disturbed or destroyed. The lock to the cabinet in which the register key had been kept had not been broken into either. There were some misplaced ceiling tiles above the register with some debris on the counter. What we do know is that whoever took the money from the register knew where we kept the key. We do know that the amount that was taken was less than \$200 because I had just made a deposit on Thursday and left approximately \$100-125 in the register. Friday a person worked and sold approximately \$50 worth of literature. Saturday, a person came in to work the office and there was no money in the register with the exception of coin / change.

Until this time, ever since the literature office has been in existence, we have never kept a daily tally of money in the literature office like every other business does for accountability.

As a result of this mess this is what we have done:

- 1. A daily sheet is in the office for whoever works to record how much money is in the office. They are responsible to enter the amount of money present in the office before they begin business and to record the amount of money at the end of their business day and initial the sheet. This is for accountability and so that we know (if this happens again) how much money is taken so we don't have to guess.
- 2. A new pad lock that is theft resistant has been purchased. This lock is resistant to bolt cutters the loop is too close to the lock for bolt cutters to get in. The lock mechanism also has a catch inside for the keys that have been made specifically for it so that it should not be able to be picked.
- 3. A safe has been purchased and bolted in. Only literature staff is allowed access to the safe, therefore only literature staff is to be in the office when opening or closing for business.
- 4. All literature staff is encouraged to make deposits as soon as they see fit to keep the amount of money at a minimum in the office. All literature staff may make deposits; however, the literature account access remains closed to the treasurer.

All literature staff members have cooperated fully and have worked very hard at brainstorming to find ways to keep future thefts from occurring. We have all looked at our own households and have all asked hard questions of those we love and trust. The fact is, is that many people have keys to a public place where people who have a propensity to steal meet. It is also a fact that before I or even Teresa came into office there may have been keys had copies made. Who knows? That is one reason I made the executive decision to have a new lock. These new actions may not do a bit of good, it may only serve as a greater challenge, but it is the best our committee could come up with.
