Motions brought to the area last month:

- **Proposal: To update the OK Region Guidelines to reflect newly formed OKNA, Inc.'s responsibility to the OK Region and to ensure that the legal requirements are met to maintain OKNA, Inc.'s 501(3)c non-profit status moving forward.**

- **Intent: To avoid lapse of OK Region's 501(3)c status.**

- **Proposal: To add a new position of Media Coordinator to the OK Regional Service Committee.**
- **Intent: Have a dedicated person to facilitate the hybrid meeting experience for virtual attendees to take the burden off of trusted servants that have other duties at the meeting.**
 - Media Coordinator
 - Two years minimum clean time requirement
 - Experience with Zoom and related equipment needed to provide effective hybrid meetings
 - Pack, store, and transport equipment for all OK Region Business meetings and other Region events requiring a hybrid option in-person
 - Arrive early to complete setup equipment and Zoom link 5 minutes before the meeting starts
 - Host the hybrid/virtual components during all meetings, including alerting the Facilitator of any chat
 - Manage camera for Zoom callers to see speakers in the room
 - Term is one year, to be voted on at the June Regional meeting
